

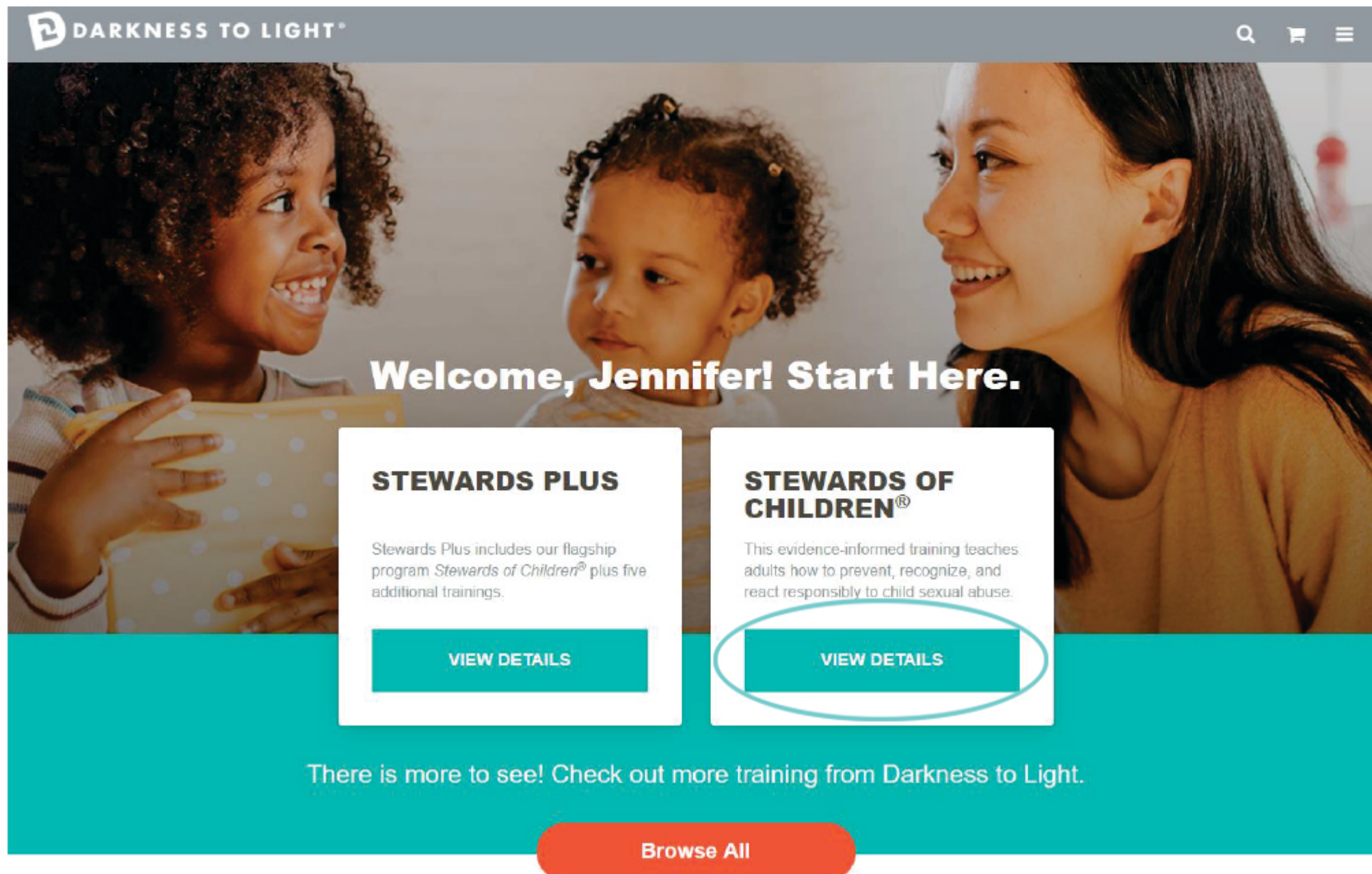


# ONLINE TRAINING USER GUIDE:

## Danbury Area Refugee Assistance

How to register for the *Stewards of Children*® online training:

1. Go to the online training registration screen via your organization's link (**Please do not use Internet Explorer to launch the training**):  
<https://d2l.csod.com/selfreg/register.aspx?c=danburyarearefugeeassistance>
2. Enter all required fields and click "**Login**".
3. Once you have completed the registration process, a "Thank you" screen will appear.
4. Now you are on your Personalized Online Training Dashboard. Once you are signed into to your online training dashboard you should see the screen below:

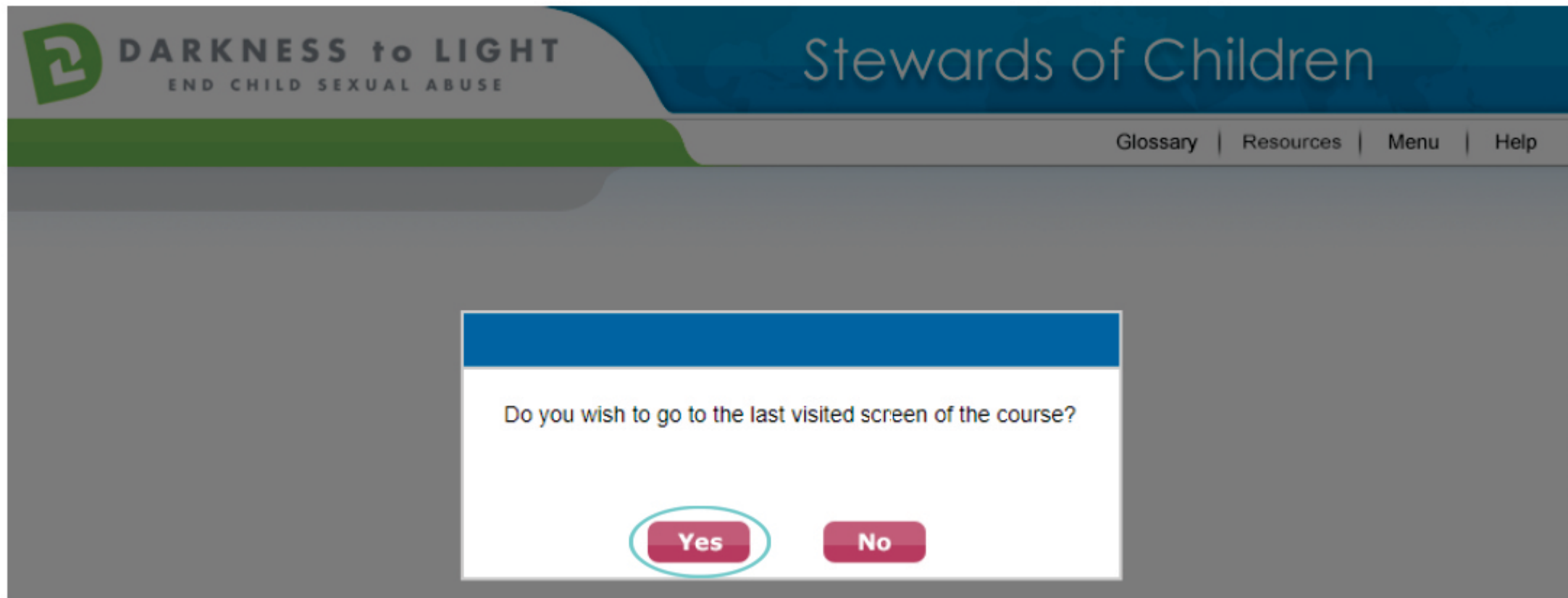

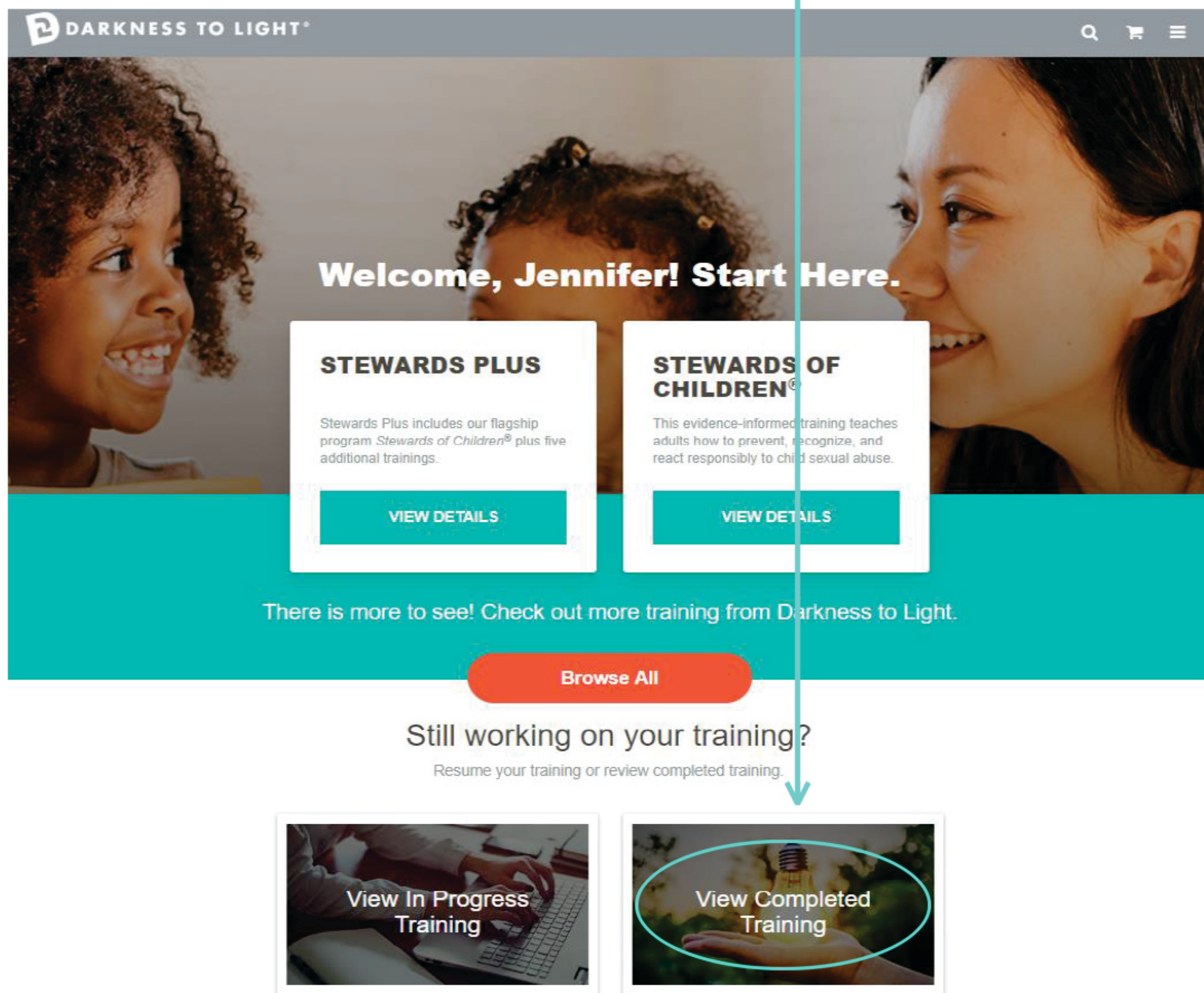

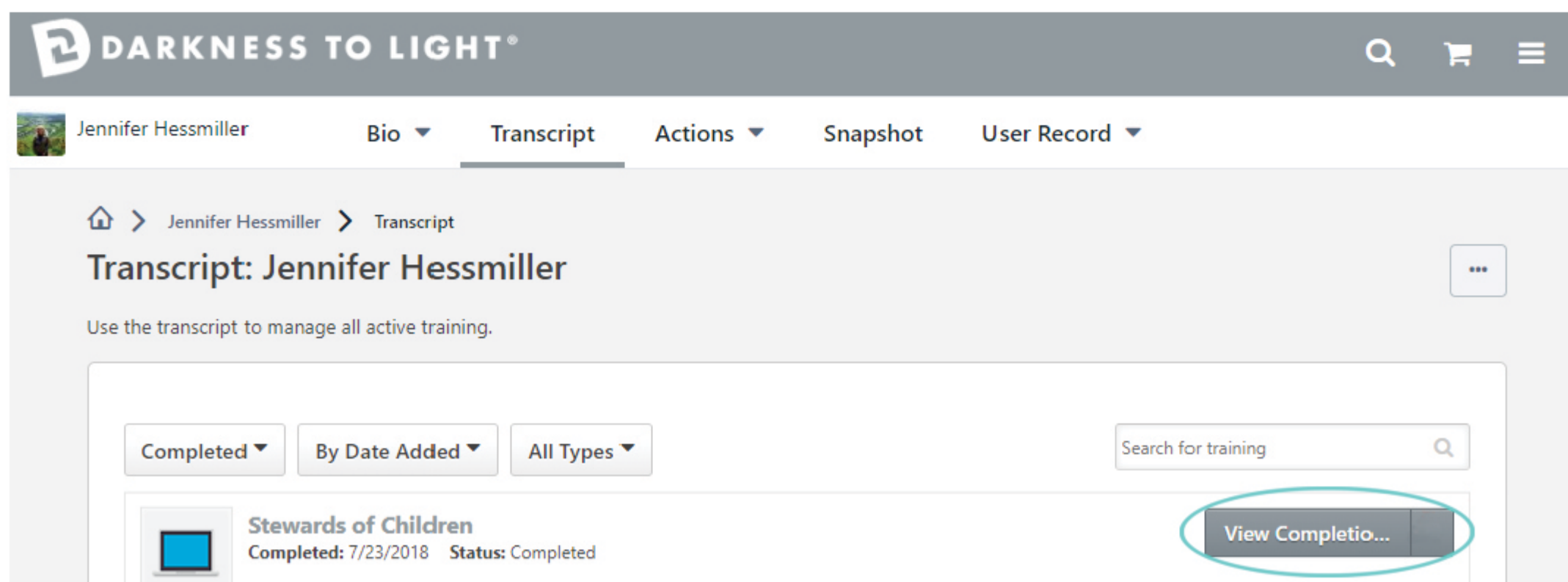


## How to Access Your Certificate
